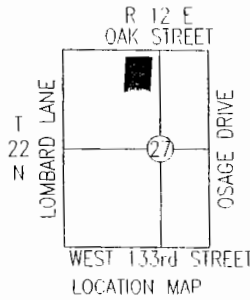
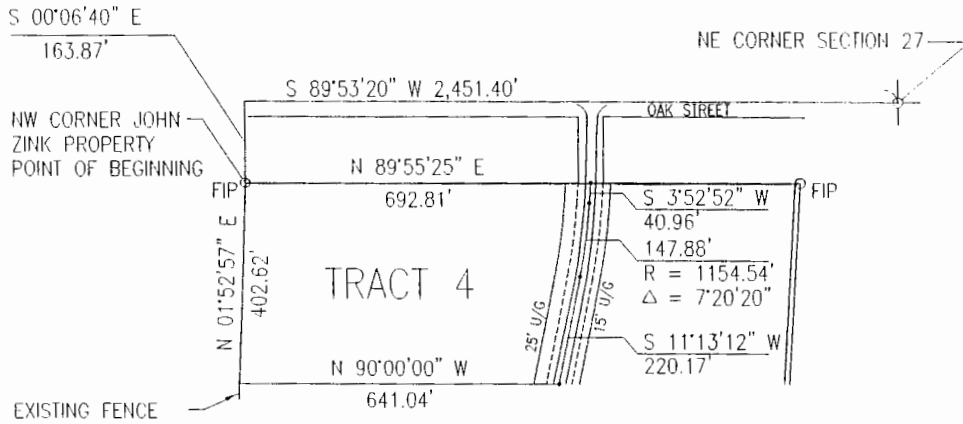
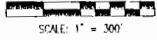


PLAT OF SURVEY

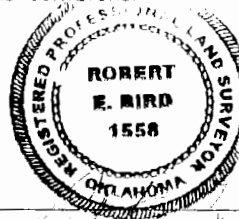
DESCRIPTION

A PARCEL OF LAND IN THE EAST HALF (E/2) OF THE NORTHWEST QUARTER (NW/4) OF SECTION TWENTY-SEVEN (27), TOWNSHIP TWENTY-TWO (22) NORTH, RANGE TWELVE (12) EAST OF THE INDIAN BASE AND MERIDIAN, OSAGE COUNTY, STATE OF OKLAHOMA, ACCORDING TO THE U.S. GOVERNMENT SURVEY THEREOF, MORE PARTICULARLY DESCRIBED AS:

COMMENCING AT THE NORTHEAST CORNER OF SECTION 27, TOWNSHIP 22 NORTH, RANGE 12 EAST THENCE S89°53'20"W A DISTANCE OF 2,451.40 FEET; THENCE S0°6'40"E A DISTANCE OF 163.87 FEET TO THE POINT OF BEGINNING; THENCE N89°55'25"E A DISTANCE OF 692.81 FEET; THENCE S03°52'52"W A DISTANCE OF 40.96 FEET; THENCE A DISTANCE OF 147.88 FEET ALONG A CURVE TO THE RIGHT HAVING A RADIUS OF 1154.54 FEET AND A DELTA OF 7°20'20"; THENCE S11°13'12"W A DISTANCE OF 220.17 FEET; THENCE N90°00'00"W A DISTANCE OF 641.04 FEET; THENCE N01°52'57"E A DISTANCE OF 402.62 FEET TO THE POINT OF BEGINNING.
